## CORPORATION OF MONTREAL

BY-LAW of the Council of the City of Montreal

concerning the appropriation of the necessary sum of money to discharge a certain debt contracted by the Magistrates of the said City for lighting the same with Gas, and concerning the appropriation of other sums of money.)

( Submitted and read the 1st time on the 22d february 1841, " " 2d time, on the 22d feb., and " " 3d time, on the 22d feb.)

The Mayor, Aldermen and Citizens of the City of Montreal duly assembled in Council at the City Hall, in the City of Montreal, on monday the twenty second day of February in the year of Our Lord One thousand eight hunderd and forty one, by virtue of the authority vested in them, in and by an Ordinance of the Governor of the Province of Lower Canada and the Special Council for the Affairs of the said Province, made and passed in the fourth year of Her Majesty's Reign intituled: "An Ordinance to incorporate the City and Town of Montreal" and also by virtue and under the authority of a certain other Act of the Governor of the said Province and the Special Council for the affairs of the said Province, made and passed in the fourth year of Her Majesty's Reign, intituled: " An Ordinance to authorize the Council of the City of Montreal to discharge a certain debt contracted by the Magistrates of the said City for lighting the same with Gas".--

DO ORDAIN and ENACT and it is hereby ordained and enacted---

Section-1-----That a sum of Nine Hundred and Fifty Pounds,

current money, of this Province, be appropriated to be paid to the Montreal Gas Light Company for so much due to the said Company by the Justices of the Peace residing in the City of Montreal for the fulfilment by the said Montreal Gas Light Company of its contract with the said Justices of the Peace to light certain parts of the said City with gas during the term of the year now expired, which contract was duly performed on the part of the said Company, to whom the said sum is now due and unpaid.--

Section 2---- And be it further ordained and enacted that a further sum of One Hundred and Thirty Nine Pounds eight-een shillings and six pence, current money, of this Province, be appropriated to be paid to the said Montreal Gas Light Company for so much due to the said Company for lighting, One Hundred and Fifty ~~lamps~~ lamps, from the eleventh day of september to the thirty first of October, One thousand eight hundred and forty inclusive, at six Pounds six shillings and eight pence per lamp per annum, and also for the lighting thirty two additional lamps from twentieth to thirty first october one thousand eight hundred and forty inclusive, at the above rate.--
