REGLEMENT MUNICIPAL no 36
15 juin 1841

CORPORATION OF MONTREAL

BY-LAW of the Council of the City of Montreal
appropriating a certain sum of money
for the maintainance of the Police
Force in the said City.

Submitted and read 1st, 2d and 3d times 15th
June 1841.

THE MAYOR, ALDERMEN AND CITIZENS of the City of Montreal
duly assembled in Council at the City Hall, in the City of
Montreal, on tuesday the fifteenth day of June in the year
of Our Lord One thousand eight hundred and forty one, by
virtue of the authority vested in them in and by an Ordinance
of the Governor of the late Province of Lower Canada
and the Special Council for the affairs of the said
Province made and passed in the fourth year of Her present
Majesty's Reign intituled "An Ordinance to incorporate
the City and Town of Montreal" and also by another
subsequent Ordinance of the said Governor and Special
Council made and passed in the fourth year of Her said
Majesty's Reign intituled "An Ordinance to amend the
Ordinance to incorporate the City and Town of Montreal",

WHEREAS in and by virtue of an Ordinance of the
Governor of the late Province of Lower Canada and the
Special Council for the affairs of the said Province made
and passed in the fourth year of Her Majesty's Reign intituled
"An Ordinance to repeal certain parts of an Ordinance
therein mentioned", it is among other things ordained
and enacted that it shall be lawful for the Commissioner
of Police for the said Province from time to time,
subject to the approbation of the Governor to furnish
to the respective ^{City} Clerks of the said cities of Quebec

and Montreal a statement or statements of the monies required for the maintainance of a good and efficient system of Police in the said Cities respectively to be by the said respective City Clerks laid before the Councils of the said Cities and the said Commissioner of Police may by his warrant or warrants require the respective Councils of the said Cities out of the funds of the same respectively to pay the amounts mentioned in the statement or statements as aforesaid,; and WHEREAS the said Commissioner of Police has submitted to the Council of the said City of Montreal a statement of the monies,namely,the sum of Twelve Hundred and Fifty Pounds required for the maintenance of a good and efficient system of Police in the said City for the quarter beginning the first day of April and ending 30th day of June one thousand eight hundred and forty one and has issued his warrant for the payment of the same, BE IT THEREFORE ORDAINED AND ENACTED and it is hereby ordained and enacted that the sum of One Thousand two hundred and Fifty Pounds be and the same is hereby appropriated for the maintenance of the system of Police as aforesaid for the quarter beginning and ending as aforesaid,and that the said sum be furnished to the said Commissioner of Police through the hands of the City Treasurer as by law prescribed.
