REGLEMENT MUNICIPAL no 37 15 juin 1841

CORPORATION OF MONTREAL

BY-LAW of the Council of the City of Montreal
authorizing the construction of a Tunnel
in a certain portion of St-Lawrence main
street and for assisting proprietors of
property on the sides of such Street.

Submitted and read 1st,2d and 3d times 15 June 1841.

THE MAYOR, ALDERMEN AND CITIZENS of the City of Montreal duly assembled in Council at the City Hall, in the
City of Montreal, on tuesday the fifteenth of June in the
year of Our Lord One thousand eight hundred and forty one
by virtue of the authority vested in them in and by an Ordinance of the Governor of the late Province of Lower Canada
and the Special Council for the affairs of the said Province made and passed in the fourth year of Her present
Majesty's Reign intituled "An Ordinance to incorporate
the City and Town of Montreal" and also by another subsequent Ordinance of the said Governor and Special Council made and passed in the fourth year of Her said Majesty's Reign intituled "An Ordinance to amend the Ordinance
to incorporate the City and Town of Montreal",

that a Tunnel or common sewer of three feet diameter be constructed in the centre of . the St-Lawrence main street from Lagauchetiere street to the main Tunnel in Craig street, be it therefore ORDAINED AND ENACTED and it is hereby ordained and enacted that the Road Committee be and they are hereby authorized and empowered to cause the construction of a tunnel or common sewer of three

feet diameter in the centre of St-Lawrence main street from Lagauchetiere street to the main tunnel in Craig street in this City and that the proprietors of property on the south west side of the St-Lawrence main street shall be assessed and shall contribute at the rate of one fourth part of the expense of a drain of two feet diameter according to the general rule of apportionment in such cases made and provided, and whereas the construction of a three feet tunnel as aforesaid will render unnecessary the drain which at present runs under the houses and property on the north east side of the said St-Lawrence street and be greatly conducive to the Health and comfort of the inhabitants thereof and will materially increase the value of such property on the said side of the street aforesaid ,it is therefore further ordained and enacted that the morth east side of the of proprietors of property on the the said part of the St-Lawrence main street shall be a same a assessed for and shall contribute and pay the expense of a tunnel or common sewer of three feet diameter as aforesaid, sa far as the same shall be made opposite their property aforesaid, less a sum equal to one fourth part of the expense of a tunnel of two feet diameter to be assessed upon and contributed by proprietors of property/ south west side of the street as aforesaid .-
