REGLEMENT MUNICIPAL no 34 15 juin 1841

CORPORATION OF MONTREAL

BY-LAW of the Council of the City of Montreal

making appropriations for lighting the City for the repairs of Roads, Streets and Bridges and for repealing a by-law therein mentioned.

Submitted and read 1st time on 14th June, 2d and 3d times 15th June 1841.

THE MAYOR, ALDERMEN AND CITIZENS OF THE CITY OF MONTAL real duly assembled in Council at the City Hall, in the City of Montreal, on tuesday the fifteenth day of June, in the year of Our Lord One thousand eight hundred and forty one, by virtue of the authority vested in them in and by an Ordinance of the Governof of the late Province of Lower Canada and the Special Council for the affairs of the said Province, made and passed in the fourth year of Her present Majesty's Reign intituled: "An Ordinance to incorporate the City and Town of Montreal" and also by another subsequent Ordinance of the said Governor and Special Council made and passed in the fourth year of Her said Majesty's Reign intituled: "An Ordinance to amend the Ordinance to incorporate the City and Town of Montreal",

SECTION 1

WHEREAS doubts have arisen respecting the validity of a certain By-Law of the Council of the said City made and passed on the fourteenth day of November in the year of Our Lord One thousand eight hundred and forty intituled: "By-Laws of the Council of the City of Montreal making the necessary appropriations for lighting the City for repairs of Roads, Streets and Bridges and for other purposes" therefore ordained and enacted the council of the city of Montreal purposes.

it is hereby ordained and enacted that the said by-law intituled" By-Law of the Council of the City of Montreal making the necessary appropriations for lighting the City for repairs of Roads, Streets and Bridges and for other purposes" be and the same is hereby Repealed.

SECTION 2

And be it further ordained and enacted that the sum of Two Thousand Pounds appropriated in and by the first section of the said By-Law for the lighting of the City from the first day of November one thousand eight hundred and forty to the first day of November one thousand eight hundred and forty one be and the same is hereby appropriated for the lighting of the said City during the period aforesaid.

SECTION 3

and be it further ordained and enacted that the sum of one thousand pounds appropriated in and by the second section of the said by-law for expenses in the repairs of roads, streets and bridges from the fourteenth day of September one thousand eight hundred and forty to the thirty first day of December of the same year be and the same is hereby appropriated for such such senses.

SECTION 4 .

and be it further ordained and enacted that a sum not exceeding one hundred and fifty pounds appropriated in and by the third section of the said by-law for the payment of various amounts due by the Magistrates of the said City to officers in their employ for arrears of salary at the time the before mentioned ordinance to "Incorporate the City and Town of Montreal" came into operation be and the same is hereby appropriated for the payment of such arrears.

SECTION 5

And be it further ordained and enacted that a sum not exceeding one hundred pounds appropriated in and

fit and proper person to be special Clerk to the Police and Health Committee and for meeting other expenses attending the fulfilment of the important duties submitted to and under the the control of the said Committee and the same id hereby appropriated for the payment of such Clerk as aforesaid.

SECTION 6

And be it further ordained and enacted that all payments of monies duly made by any officer of this Corporation or by any Committee thereof for an account of all or any of the various appropriations in the said repealed by-law mentioned are hereby approved.
