REGLEMENT MUNICIPAL no 45 4 septembre 1841

CORPORATION OF MONTREAL

BY-LAW of the Council of the City of Montreal appropriating certain sums of money for the purchase of certain proper ties therein mentioned.

Submitted and read 1st and 2d times 28th August and 3d time 4th September 1-841.

THE MAYOR, ALDERMEN AND CITIZENS of the City of Montareal duly assembled in Council at the City Hall, in the City of Montreal, on saturday the fourth day of September in the year of Our Lord One thousand eight hundred and forty one, in virtue of the authority vested in them in and by an Ordinance of the Governor of the late Province of Lower Canada and the Special Council for the affairs of the said Province made and passed in the fourth year of Her present Majesty's Reign intituled "An Ordinance to incorporate the City and Town of Montreal" and also by another subsequent Ordinance of the said Governor and Special Council made and passed in the fourth year of Her said Majesty's Reign intituled "An Ordinance to amend the Ordinance to incorporate the City and Town of Montreal",

WHEREAS it has been deemed adviseable and conducive to the interests of the City of Montreal to purchase
and appropriate certain properties on Commissioners square, Craig, St-Radegonde, Jury and Lagauchetiere streets, specified by the Committee on Roads and Improvements in their
report of the fourteenth day of August last past for the
purpose of public improvements, and WHEREAS the sum of One
Thousand Six Hundred and Ninety Four Pounds fourteen shillings and four pence currency is immediately requisite for

the purchase and appropriation of the said properties for the purpose aforesaid.

BE IT THEREFORE ORDAINED AND ENACTED and it is hereby ordained and enacted that the sum of One Thousand Six Hundred and Ninety Four Pounds fourteen shillings and four pence shall be and the same is hereby appropriated for the payment of the purchase and appropriation of the properties aforesaid, namely, the sum of Seven Hundred Pounds for the payment of the first instalment due on portions of property purchased from the heirs and representatives of the late Pierre Foretier, esquire, and the sum of Two Hundred and Seventy Five Pounds for payment of the price or value of property belonging to E.Delaunai on St-Radegonde street and the sum of One Hundred and fifty pounds for payment of the price or value of a portion of the property belonging to the heirs and representatives of the late John Delisle, esquire, situated on St-Radegonde street, and the sum of Forty Pounds for the price or value of a portion of the property belonging to John Donigani, esquire, on St- Radegonde street, and the sum of One Hundred and Seventy Pounds fifteen shillings for the price or value of a portion of property belonging to McGill Desrivieres, esquire, situated on St-Rade-- and Lagauchetiere streets, and the sum of and the sum of Two Hundred and thirty eight Pounds nineteen shillings and four pence for the payment of the price or value of property belonging to the heirs and represen**t**ativos of the late Huguet Latour, situated on Lagauchetiero street, and the sum of One Hundred and Twenty Pounds for payment of the price or value of a portion of the pro-
