REGLEMENT MUNICIPAL no 7 16 novembre 1866

CORPORATION OF MONTREAL

BY-LAW to remove the Hay Market from Victoria Square to the old College Garden on College street.

WHEREAS it has been deemed expedient to remove the Hay Market and Weigh-House from Victoria Square to the lot of ground recently acquired by the Corporation of this City from the Gentlemen of the Seminary of St-Sulpice and commonly known as the "College Garden",

At a Special Meeting of the Council of the City of Montreal held in the City Hall of the said City, this sixt teenth day of November in the now year of Our Lord one thousand eight hundred and sixty-six, under and by virtue of the Act of the Provincial Legislature 14 and 15 Vict, ch. 128 in the manner and after observance of all the formalities prescribed in and by the said Act, at which said Meeting not less than two-thirds of the members of the Council, to wit: the following members thereof are present, viz: His Worship the Mayor Henry Starnes, esquire, ALDEMMEN: Contant, Gorrie, David, Bowie, Rolland, Stevenson, Rodden, Goyette, COUNCILLORS: McGauvran, Donoven, Poupart, Ogilvie, Basrien, Brown, Leduc, Lanctot, St-Charles, Masterman,

THE IS ORDAINED AND ENACTED by the said Council and the said Council do hereby ordain; and chact as follows:

SECTION 1--The Hay Market and Weigh-House established on Victoria Square in this City shall be changed and removed to the lot of ground so as aforesaid purchased from the Gentlemen of the Seminary of Montreal and which is bounded by College Inspector, William and George streets.
SECTION 2--The said lot of ground in the preceding section described shall be and the same is hereby constituted

and established "The Hay Market, number One" of this City, in lieu and place of the Hay Market heretofore existing and established on Victoria Square in this City shall be changed and removed to the lot of ground so as aforesaid purchased Afrom the Gentlemen of the Seminary of Montreal and which is bounded by College, Inspector, William and George streets .-SECTION 2 -- The said lot of ground in the preceding section described shall be and the same is hereby constituted and established "The Hay Market number ONE" of this City in lieu and place of the Hay Market heretofore existing and established on Victoria Square, which said latter Hay Market is hereby and from henceforth abolished, and the weigh-house and scales recently erected on the above described lot of ground shall be the weigh-house and scales to be hereafter and hence forth used and employed in weighing hay, straw, etc., in lieu: and place of the weigh-house and scales on Victoria Square heretofore used for that purpose .--

SECTION 3-- All the provisions of By-Law chapter xlx(of the Consolidated By-Laws) which relate to govern or in any way concern the said Hay Market on Victoria Square or the weighhouse and scales thereon or the Clerk thereof (who is hereby constituted and appointed the Clerk of the new Hay Market and weigh-house hereby established on the above described lot of ground) shall extend and apply to the said new Hay Market, to the said weigh-house and scales thereon and to the said Clerk thereof and shall be in as full force and operation and have as much effect on the said new Hay Market and in relation to the said weigh-house and scales thereon and with the Clerk thereof, as if the said provisions had been enacted expressly for and in relation to the said new Hay Market and the said weigh-house and scales thereon and the said Clerk thereof; and all and every the duties, rates and taxes heretofore imposed, levied and collected on the said Hay Market on Victoria Square, under and by virtue of the said By-Law chapter xlx shall from henceforth be imposed, levied and collected on the said new Hay Market hereby established, in the said weigh-house thereon and by the said Clerk thereof in the like form and manner that the same heretofore have been and are imposed, levied and collected on the said Hay Market on Victoria Square, in the said weigh-house thereon and by the said Clerk thereof .-STARNES?mayor. TO REMOVE THE HAY MARKET FROM VICTORIA SQUARE TO THE OLD COLLEGE GARDENON COLLEGE STREET.

WHEREAS it has been deemed expedient to remove the Hay Market and Weigh-House from Victoria Square to the lot of ground recently acquired by the Corporation of this City from the Gentlemen of the Seminary of St. Sulpice, and commonly known as "The College Garden."

At a Special Meeting of the COUNCIL of the CITY OF MONTREAL, held in the City Hall of the said City, this SIXTEENTH day of NOVEMBER, in the now year of our Lord, one Thousand Eight Hundred and Bixty-six, under, and by virtue of the Act of the Provincial Legislature, it and is Victoria, cap. 123, in the manner and after observance of all the formalities prescribed in and by the said Act; at which said meeting not less than two-thirds of the Members of the Council, to wit, the following Members thereof, are present, viz.:—His Worship the Mayor, Henry Starnes, Esquire; Aldermen Contant, Gorrie, David, Bowle, Rolland, Sievenson, Rodden, Goyette; Councillors McGauvran, Donovan, Poupart, Oglivie, Bastien, Brown, Leduc, Lanctot, St. Charles, Masterman;

It is ordained and enacted by the said Council, and the said Council do hereby ordain and enact as fellows:—

SEC. 1.—The Hay Market and Weigh House, established on Victoria Square, in this city, shall be changed and removed to the lot of ground, so as aforesaid purchased from the Gentlemen of the Seminary of Montreal, and which is bounded by College, Inspector, William and George Streets.

BEG 2.—The said lot of ground in the preceding Section described, shall be, and the same is hereby constituted and established "THE HAY MARKET, NUMBER ONE," of this City, in Iteu and place of the Hay Market beretofore existing and established on Victoria Square, which said latter Hay Market is hereby, and from henceforth abolished; and the Weigh House and scales recently eracted on the above described lot of ground shall be the Weigh House, and Scales to be hereafter and henceforth used and employed in weighing hay, straw, &c., &c., in licu and place of the Weigh House and Scales on Victoria Square, heretofore used for that purpose.

SEC 3.—All the provisions of By-law, Chap. XIX, (of the Consolidated By-laws) which relate to, govern, or in any way concern the said Hay Market on Victoria Square, or the Weigh house and scales thereon, or the Clerk thereof (who is hereby constituted and appointed the Clerk of the new Hay Market and Weigh House hereby established on the above described lot of ground,) shall extend and apply to the said new Hay Market, to the said Weigh House and Scales thereon and to the said Cierk thereof; and shall be in as full force and operation, and bave as much effect on the said new Huy Market and in relation to the said Weigh House and Scales thereon and with the Clerk thereof, as if the said provisions had been enacted expressly for and in relation to the said new Hay Market and the said Weigh House and Scales there on, and the said Clerk thereof; and all and every the duties, rates and taxes heretofore imposed levied and collected on the said Hay Market on Victoria Square, under and by virtue of the said By-Law, Chapter XIX. shall from henceforth be imposed, levied and collected on the said new Hay Market hereby established, in the said Weigh House thereou and by the said Clerk thereof, in the like form and manner that the same heretofore have been and yet are imposed, levied and collected on the said Hay Market on Victoria Square, in the said Weigh House thereon and by the said Clerk thereof.
