Respectfully Report,

That for some time past they have noticed in the city newspapers a notice of sale by auction of a residence and grounds outside the Côte des Neiges toll gate adjoining the Park property and belonging to Mr. ^{H. Hodgson} Hudson.

That, in their opinion, this property covering an area of about 25 arpents, would be a desirable acquisition to the Park.

With that view they instructed the chairman to attend the ~~auction~~ ^{sale} and purchase the same and they beg now to report that the purchase was made for the sum of five thousand dollars and 2% auction commission.

Your Commissioners therefore recommend that the action taken by them ~~be~~ be approved of by the Council and that an appropriation of the said sum of \$5100. be made to them out the Park loan for that purpose.
