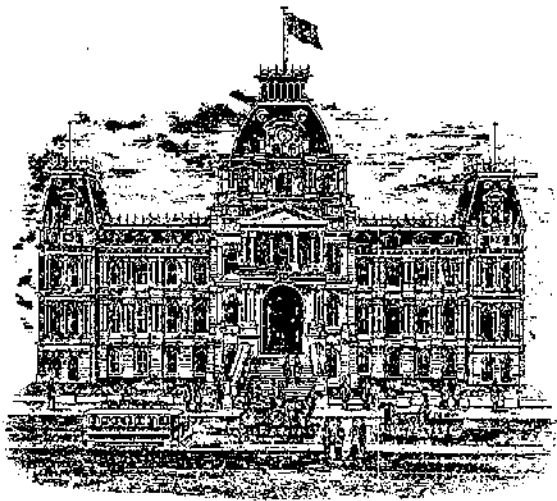


We are in receipt of a letter from Mr. J. O. A. Laforest, Superintendent of Water Works, in reply to our letter to you of the 14th inst., in which it is stated that the Water Committee will probably not be disposed to pay the amount asked for in our letter as the work is not completed and not ready to test.

We have replied to Mr. Laforest stating that we consider this an injustice. It is not our fault that the work is not completed and tested. We have been unable to obtain the required location for the fan and engine, moreover our Boilers have been in constant operation for months past, and we are ready to complete the work as soon as the locations are determined.

We are badly in need of money at present and in view of the fact that the Boilers have been operated with the present draft for so long now we feel that we are entitled to receive the amount that we have asked for, and we trust that you will arrange this for us.

We beg to call your attention to our Water Supply at the Home at Longue Pointe. In June 1885 we had a notarial agreement with the City of Montreal for a supply of water to our Institution, it being for the city poor, at the price for City Institutions for fifteen cents per one thousand gallons. We laid pipes to connect with City at Maisonneuve (over 2000 feet) at a cost of \$1700.00. That arrangement has been continued to the present, and we are still supplied through the City's metre. The Montreal Power and Water Company has now sent us a bill for water from January, 1899 to September, charging us twenty-five cents per one thousand gallons.

We appeal to you and your Committee to protect us in our rights.

Regarding Water Meter Rates Montreal Cold Storage & Freezing Co, I enclose herewith diagram showing our buildings which will perhaps ^{aid} ~~lead~~ you in understanding this question.

You will note that they constitute practically one large building, Fire walls having been built between, to meet the requirements of the Underwriters Association.

This business was originally begun in 1892 in Warehouse marked No. 604 to 610 St. Paul St, and addition after addition has been erected as required.

In 1894 when building No. 61 to 69 William Street was ^A in course of erection, three Butter and Cheese Firms offered to rent from us Stores, consisting of the Basement and Ground Floors, in these buildings if built in a certain way, and upon consideration we decided to accept their offer, and thereupon rented these three Firms the Cellars and Ground Floors, reserving for our own Cold Storage business the two Upper floors.

We found this an advantageous and profitable arrangement and have since, when building, always tried to secure tenants for the Basement and Ground floors of any warehouses we erected, the result being that at the present time nine tenths of our immense Storage business is done in these Upper floors.

You will appreciate the soundness of this policy from a business standpoint when I explain that we can obtain from tenants rentals, almost equal in amount to the interest on Land and Buildings erected, which leaves us our Cold Storage Chambers almost free of cost.

For instance, - Suppose the total cost of our Land and Buildings at present to be \$300,000. representing in Interest to our Company an Annual charge of 6 p.c or \$18,000.-, by judiciously renting the Lower floors we derive a revenue in rentals of say \$15,000.- and have consequently our immense Cold Storage capacity in the Upper floors at a cost of \$3,000.- per Annum, and Upper Stories are quite as good for Storage purposes as the Lower.

If we did not rent these Lower floors we would require only say about half the Buildings costing half the amount or say \$150,000. which at 6 p.c would represent \$9000.- per Annum as against the cost to us the other way of probably less than \$3000.-

In addition to the above consideration we found it paid to secure tenants in this way, as we thus secured any goods which these Firms required to Store, for the reason that so long as our Gold Storage rates are the same as those of competing Companies we are given the preference.

The present situation therefore is, we cannot reach our Storage Sections in the Upper stories in these buildings without Elevators and the Sup.t of the Water Department, a year or so ago, undertook to notify ourselves and our tenants, occupying the lower floors where there happened to be Elevators ~~would~~ ^{that}, for instance,-- because Messrs D.A.McPherson & Co., occupy the Cellar and Ground floor of 71 and 73 William St, that D.A.McP.&Co must pay the Water Meter rate on Elevator in that building, which we use to reach our Refrigerators in the three Upper floors, now D.A.McP.& Co never rented from us anything except the Cellar and Ground floor

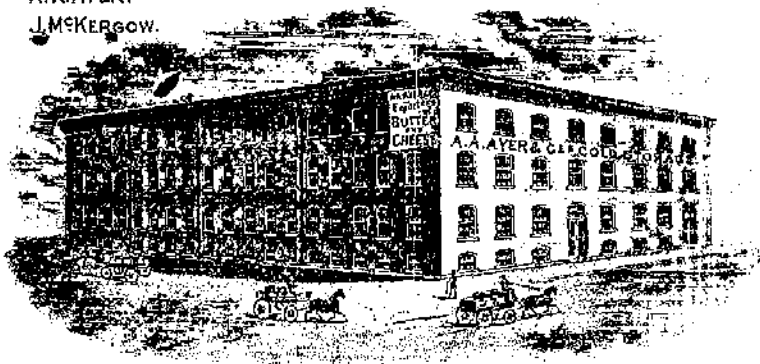



3. When assessed at a yearly rental exceeding \$150 but not over \$200..... 22.00

And so on, continuing according to the same scale, that is to say, adding for every additional sum of \$50 or any part thereof, *Five Dollars*..... 5.00

Provided that for hotels whose assessed rental per annum will be \$400 and over, and which will be provided with at least twenty furnished rooms for the accommodation of travellers, water shall be charged by meter and paid for at the same rate as distilleries, Breweries, &c.

HAND HOSE.

Per Annum.

For the right to attach and use a hose of not more than one-fourth of an inch orifice, for watering purposes..... \$2.00

BUILDING MATERIALS.

Payable in advance.

For every thousand bricks used, the water therefor to be charged \$0.06

For every toise of masonry, the water therefor to be charged..... 0.05

For every thousand yards of plastering..... 4.00

FOUNTAINS.

Fountains shall only be supplied with water at the discretion of the water committee,

and when so supplied shall be charged as follows :

For every 100 gallons of water..... 0.08

The quantity used to be determined in all cases by the estimate of the water committee or by meter.

BATHS.

Per Annum.

Public baths, or baths for the use of which a charge is made—for each tub..... 6.00
—with power to the water committee to charge by meter if they see fit.

HORSES AND COWS.

Per Annum.

For each horse..... \$2.00

For each cow 1.00

Livery stable keepers shall pay—for each single stall, whether occupied or unoccupied..... 2.00

Hotel and tavern keepers shall be charged—for each single stall, whether occupied or unoccupied..... 1.00

WATER CLOSETS.

(As amended by sect. 3 of by-law No 155 passed 23rd May 1887.)

Per Annum.

For each pan closet supplied from a cistern, with a service box and valve..... \$4.00

For each pan closet with Underhayes, or any other regulator approved of by the water department 8.00

For each hopper closet with Underhayes, or any other regulator approved of by the water department	3.00
For each closet of any kind, with cistern, service box, and double valve.....	4.00
Trough closets with self-acting valve, or cock, for each seat, or for every two lineal feet...M..	3.00
For any other kind of closet, each.....	15.00
In dwellings where there is more than one water closet, each additional water closet shall be charged at half rates.	

“ In dwelling houses or tenements assessed on a yearly rental of one hundred and fifty dollars or under, no charge shall be made for water closets : provided that the exemption thus granted, shall not be held as depriving the city from the right to cut off the supply of water in all cases of non-payment of the ordinary annual water-rates.”

STEAM ENGINES.

For stationary low pressure engines : for every 100 gallons of water (the supply to be determined as above, by meter)..... 0.03

All rates herein imposed for steam engines shall be separate from and over and above any other rate for water imposed on the premises.

DISTILLERIES, BREWERIES, &C.

(As amended by sect. 1 of by-law No 82 passed 12th October 1874.)

Distilleries, breweries, dye houses, railway, printing and photographic establishments, and all manufacturing establishments, colleges, seminaries, nunneries, hospitals, asylums, academies, houses of industry and reformatories, may be supplied by meter and charged as follows :

When the quantity used averages 1,000 gallons per day or less, at the rate of 30 cents per 1000 gallons ; when the quantity used averages from 1,000 to 2,000 gallons per day at the rate of 29 cents per 1,000 gallons.

From 2,000 to 3,000	28 Cents.

When the quantity averages over 10,000 gallons per day, 15 cents per 1,000 gallons.

Provided that charitable institutions, wholly supported by means of public subscriptions shall be charged at the rate of one and a half cents per 100 gallons.

(As amended by section 2 of by-law No 82 passed 12th October 1874.) The meters shall be furnished by the city and placed within the premises of the consumers whose duty it shall be to see that the same are protected from frost or injury, the whole under the direction of the water department; such meters shall at all times be accessible to the corporation meter inspector.

An annual rent shall be paid by the consumers for the cost and care of such meters, as follows :

For a $\frac{1}{2}$ inch meter	\$ 3 00	per annum.
For a $\frac{3}{4}$ " "	3 75	"
For a 1 " "	4 75	"
For a $1\frac{1}{2}$ " "	8 00	"
For a 2 " "	14 00	"
For a 3 " "	25 00	"

For a 6 " "	100 00	"

The above rent to be paid semi-annually, that is to say : one half on the first day of May and the other half on the first day of November in each year.

Persons desirous of supplying their own meter may do so with the previous sanction and written permit of the superintendent of water works.

When water is required for purposes not specified in the foregoing tariff, the rate shall be fixed by the water committee.

The water committee shall have power to ascertain, by meter, the quantity of water used in any of the above cases, and charge accordingly.

always found this meter working
and called Mr. Traddels attention to the
fact, and they further state that the

their opinion are accountable for the
heavy consumption during the
hot weather.

If this large amount of water was
consumed ~~about~~ paying by meter, and



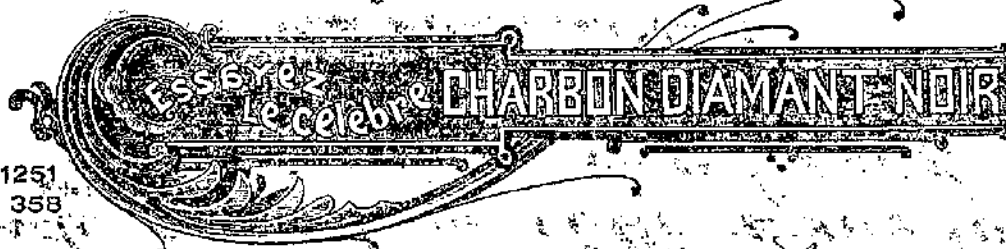

Iron refrigerating pipes are put through the walls of each building, a separate business tax is imposed upon a number of these upper flats though Mr Chisholm the manager last year strongly opposed this business tax on these flats they have

have not done so this year.

The other Cold Storage Companies do not let any part of their premises to me, charter; but use the whole for cold storage. One of them is run by electricity which is cheaper than by water.

motive power for moving our Elevators and if the City sees fit to cut off the Water it would result in damages to the extent of hundreds of thousands of dollars which we consider we can hold the City responsible for.

Mr. Laforest claims to have a letter from one of our tenants saying that they paid us for the Water used by the Elevator. I have enquired and find that this letter was written in response to a notification sent this Firm by Mr. Laforest informing them that in future the City would hold them responsible for, and look to them for payment of the water used by Elevator which runs through their Store, this Firm telephoned our Office and enquired the meaning of the Water Department's letter, stating to us that they had nothing to do with the Elevator and were told by us that this was quite correct as our rates of Storage include elevating the same as any other Company's, according they wrote back stating they paid us the Water, which they do indirectly the same as when storing goods in any other Warehouse.

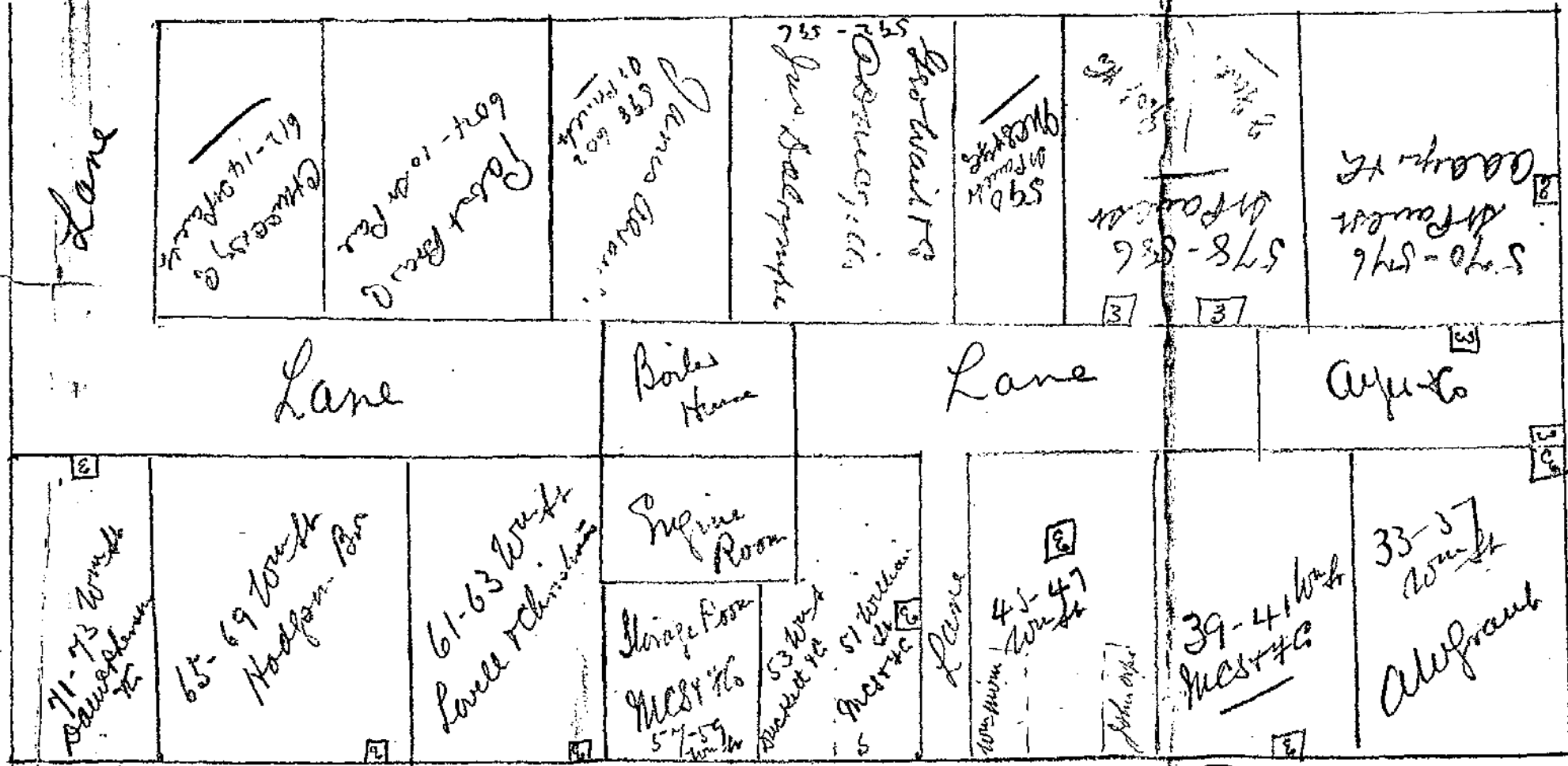

We may say that the Pabst Brewing Company at 606 St. Paul, Street, use more or less water for bottle washing etc, which unquestionably they should pay for direct to the City, a Meter for their use can be placed on the same Main, as our Meter, at a point between our Meter and the outside wall of building, where it would not interfere with the reading of the Meter which we use.

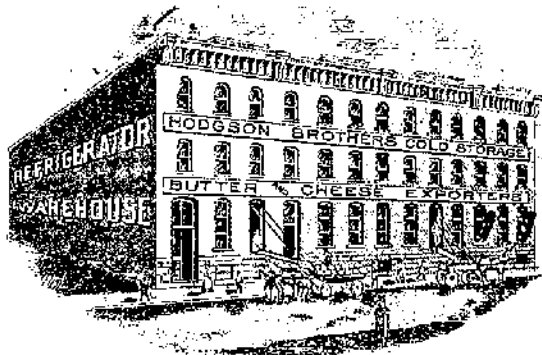
I may say that the last seven Elevators which we have erected are operated by Electricity simply to avoid the chance of further inconvenience consequent upon what we consider the gross stupidity of the Superintendant of your Water Department.

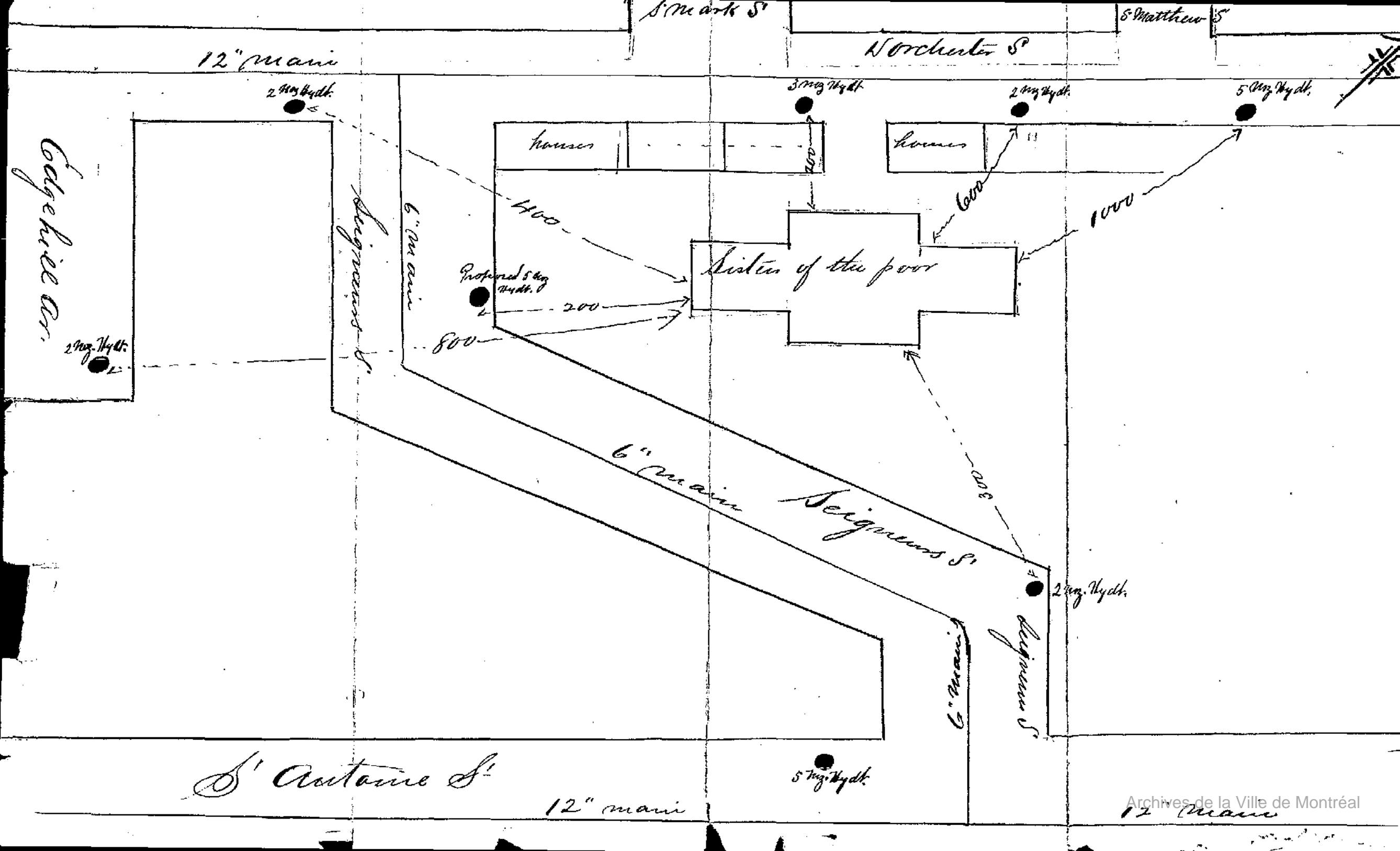

BY-LAW

TO PROVIDE FOR THE CARE AND MANAGEMENT

OF THE

MONTREAL WATER WORKS

AND TO ESTABLISH

A TARIFF OF WATER RATES

PASSED 29TH APRIL 1873

(AS AMENDED BY SUBSEQUENT BY-LAWS.)

At a special meeting of the council of the city of Montreal, this twenty-ninth day of April, in the year of Our Lord one thousand eight hundred and seventy-three, after the observance of all the formalities prescribed by law ; at which said meeting, not less than two thirds of the members of the council, to wit, the the following members, are present, viz :

His Worship the Mayor, Francis Cassidy, Esquire ;
ALDERMEN Bastien, Wilson, Simard, Bernard, Alexander, David, Kay ; COUNCILLORS McShane, Stephens, Garth, Hood, Mullin, Loranger, Rolland, McCambridge,

Kennedy, Grenier, Munro, Nelson, Rivard, Jodoin, Thomas, Bryson.

IT IS ORDAINED and enacted by the said council, as follows:

Sec. 1. The water department of this city shall be under the direction of the water committee, without any prejudice, however, to the city revenue.

Sec. 2. The superintendent of the water works shall take such charge of the aqueducts, reservoirs, and other works and property, as well as of all plans belonging to or connected with the water works, as the water committee may from time to time direct; and he shall perform all such services in relation thereto, as may be required of him, by the said committee or by the city council.

Sec. 3. The said superintendent shall, on or before the fifteenth day of March, annually, present to the city council a report of the general condition of the water works, and such other matters as he may deem expedient, accompanied by any information or suggestion, which he may deem necessary.

Sec. 4. The superintendent of the water works, and the officials and employees of his department are hereby named and appointed as inspectors under the Act of the Province of Quebec, 36 Vict. cap. 54; and they may enter, at reasonable hours, to wit: between ten o'clock in the morning until four o'clock in the afternoon, into any house or building supplied with water from the said water works, and upon and traversed by the water of the said water works, to examine the cocks, pipes, meters, cisterns, reservoirs or

other apparatus, for the purpose of ascertaining the quantity of water consumed, or supplied, or for placing or carrying away any meter, instrument, pipe, fitting, or other work belonging to the said corporation.

Sec. 5. It is expressly forbidden to any occupant of a house or building, or any part thereof, supplied with water from the said water works, to furnish water to others, or to use it otherwise than for his own use, or to increase the supply of water agreed for, or to waste it, or to practise any fraud upon the said corporation with regard to the water so supplied.

Sec. 6. All persons taking the water shall keep the distribution pipes within their premises in good repair, and protected from frost, at their own expense; and they shall be held liable to the corporation for all damages that may result from their failure to do so.

Sec. 7. No person shall fraudulently connect any pipe with the water pipes of the corporation, or with any pipe, cistern or apparatus connected therewith, or to or into which the water from the said water works shall flow or proceed,—or shall fraudulently use or otherwise mis-appropriate the water supplied by the city, or knowingly permit the same to be fraudulently used or otherwise mis-appropriated.

Sec. 8. If any person supplied with water by the corporation do, or permit to be done, anything in contravention of this by-law, or fail to do anything prescribed by this by-law, the superintendent or his deputy may cut off the water supply, and cease to supply such person with water so long as the cause of complaint remains, or is not remedied.

Sec. 9. No person shall wrongfully cause or suffer any pipe, valve, cock, cistern, bath, soil-pan, water closet, or other apparatus or receptacle to be out of repair, or to be so used or contrived as that the water supplied to him is or is likely to be wasted, mis-used or unduly consumed.

Sec. 10. No alteration shall be made in any of the pipes or fixtures inserted by the city, except by its agents or officers.

Sec. 11. No person supplied with water from the said water works by meter shall be allowed to connect, or cause to be connected, any pipe or other fixture between the corporation's service pipe and the meter.

Sec. 12. No person, unless duly authorized by the water committee, shall open any hydrant in the city, or lift or remove the cover of, or draw water from the same.

Sec. 13. No person shall turn on, or turn off the water in any manner, or interfere with any of the water pipes or valves belonging to the city, without the permission of the water committee or of the said superintendent.

Sec. 14. No person shall pass the railing enclosing the reservoirs of the city, or shall defile or deposit any filth or offensive matter in the said reservoirs, or on the bank or ground adjacent thereto, belonging to the city, or shall allow any dog or other animal to jump into the said reservoirs, or upon the said bank or ground, or shall pass or remain upon the said bank or ground after ten o'clock in the evening; or shall do or cause anything to be done tending

to defile or corrupt, to disturb or agitate the water of the said reservoirs.

Sec. 15. No person shall draw water from the river St. Lawrence or elsewhere for the purpose of selling the same in any part of the city.

Sec. 16. No person shall draw or use water from the water works in the city for private fountains, or for hand-hose for watering purposes, or for building or manufacturing purposes, unless such person shall have previously obtained from the superintendent of the said works a written permission to that effect, and paid the respective rates charged in the subjoined tariff for the supply of water in such cases; and in no case shall the said hose be used for sprinkling or watering the streets between 9 o'clock in the forenoon and 5 o'clock in the afternoon.

Sec. 17. No person shall use any hand-hose of a larger size or nozzle than one-fourth of an inch orifice, or use any hand-hose for the purpose of washing horses, coaches, omnibuses, or other vehicles.

Sec. 18. No meter shall be used for determining the quantity of water supplied by the said works, unless the same shall have been previously submitted to and approved by the said superintendent.

Sec. 19. The several rates enumerated and specified in the tariff contained in the subjoined schedule, shall be, and the same are hereby imposed for water to be supplied from the water works of the said city.

Sec. 20. (*As amended by sec. 1 of by-law No. 155 passed 23rd May 1887*). The said rates shall be due and payable to the city treasurer, in advance on the

fifteenth day of August every year, by the occupant or lessee, or occupants or lessees of all buildings, part of buildings or tenements in the city, supplied with water from the said works, as well by those who shall consent, as by those who shall refuse, to receive the water pipe to supply the said water, or to use the same. " *Provided that in all cases of tenants or occupants of dwelling houses assessed on a yearly rental of one hundred and twenty dollars or under, the said rates shall be payable every year in two instalments, viz : on the fifteenth August and fifteenth November.* "

Sec. 21. All charges for specific supplies, or for fractional parts of the year, shall be payable in advance and before the water is let on.

Sec. 22. In buildings occupied as offices where there are water closets in the building, each tenant of an office, or suite of offices, will be charged in addition to the tariff rates, a water-closet tax.

Sec. 23. *(As amended by section 2 of by-law No. 155 passed 23rd May 1887.) " A discount of five per cent shall be allowed to all water tenants who will pay in one instalment the whole of the said rates on or before the fifteenth August in each and every year. "*

Sec. 24. In all cases of non-payment of the rates imposed by the present by-law, for thirty days after the same are due, the said council or any duly authorized officer charged with the management of the said works, may cut off the supply of water from any building upon which the said rates shall be due, or from anyone in default to pay the said rates ; which shall not prevent the said rates from running as before, and

the water shall not be let on, for the use of any such defaulter, except upon payment of all arrears due.

Sec. 25. Any person offending against any of the provisions of this by-law, or of the said tariff shall for each and every such infraction be liable to a fine not exceeding twenty dollars and costs of prosecution, and, in default of immediate payment of the said fine and costs, to an imprisonment in the common gaol for a period not to exceed two months, the said imprisonment to cease upon payment of the said fine and costs.

Sec. 26. The by-law, number fifty-one, passed by the council of the said city, on the fifteenth day of March, one thousand eight hundred and seventy, and intituled " By-Law to provide for the care and management of the Montreal Water Works, and to establish a tariff of water rates, " and the second section of the by-law, number two, passed by the said council on the sixteenth day of April, one thousand eight hundred and sixty-six, intituled " By-law to allow a discount on water rates in certain cases, and to charge interest on arrears of assessments, taxes and water rates, " — shall be and the same are hereby repealed.

 Every building used as a college, academy, seminary of learning or school, all churches, poor or alms houses, nunneries, houses of industry, and generally all religious or charitable institutions, hospitals and reformatories shall be charged at shop rates, to be based and determined upon the interest, at four per cent. of the actual value of the property in each case, the said value as set forth and established in and by the assessment roll last made and revised; *provided that all such institutions with the exception of churches, may, if they see fit, use water by meter and pay therefore at the same rate, as distilleries, breweries and other establishments hereinafter mentioned.*

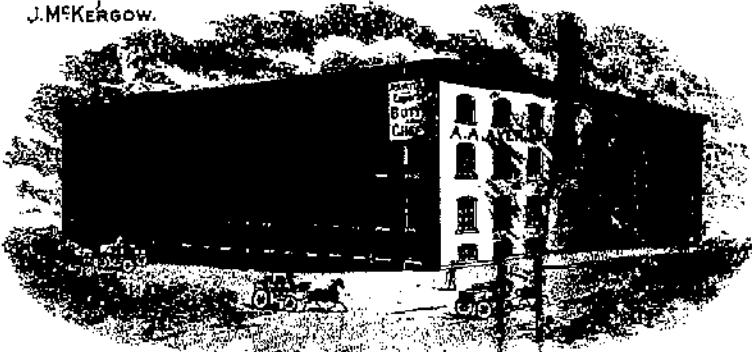

If the Montreal Cold Storage Company furnishes us with the money to pay for the use of them we will willingly hand it over to you, but we certainly cannot assume any responsibility in the matter. Nothing would please us more than to have them do away with water and put in some mechanical power for the running of the elevators.

Gentlemen

At your request to be furnished with a statement showing the consumption of water by meter, & other information regarding the Montreal Cold Storage & Freezing Coy., I beg to submit the following brief report, with Statement & Sketch attached.

These premises are large Cold Storage warehouses occupying the block between St. Paul & William Streets opposite Queen. & is divided up & rented to different tenants.

The Elevators are run by water power & metered by 9 meters 1.6" - 2.4" & 6.3" in some cases two or more tenants use the same elevator, or there are two or more elevators on the one meter. I find it almost impossible to get the division of the tenants. The meters were connected at the request of the Coy & charged to them, although each tenant pay their own water assessment direct to the City for the domestic supply which is not metered.

The M.C.S. Coy may have the use of one or more elevators themselves as they require, besides this they take what water is required for use of their Boilers & Freezing purposes from one or more meters, but have a well which they can use for this purpose.

The "Pabot" Brewing Coy to May 98 was on M. Bill for 6 meters. They paid at the rate of 29¢ per m. gal. They notified us to remove the meter as they were moving to M.C.S. Coy. I called and saw their Supt. & Manager who informed me that they had an arrangement with the Coy for hot power & water, & had refused to have a meter for that purpose. Consequently the Coy have ~~them a connection of their large main used for~~ ~~their~~ ~~boilers~~, this gave them water at 10¢ instead of 29¢.

I brought the matter before the Supt., when it was decided to charge the rate as per consumption of each meter instead of the combined meter - the result of this as shown on the statement is increased revenue to the amount of \$461.62 for last 12 months. If I understand properly the Coy collect the amount of meter account from the tenants as rendered by the City to them, which is lumped together means a reduced rate for each.
