Dear Sir

Will you be pleased to present to Council tonight this my resignation as a Member of the "New City Hall Committee"

I regret feeling called upon to take such a course, and I would not do so but for the fact that a large majority of the Committee persist ^{in a course} unauthorised by Council and in my humble opinion detrimental to public interest, as follows

- 1st The architects were instructed to prepare plans & to this day no arrangement has been made with them for their charges.
- 2nd Their amended plans were submitted to the Committee last night for the first time and at once adopted, without specifications & estimates as ordered by Council.
- 3rd It is believed, the building when finished will cost much more than the sum limited by order of Council.

It is well known that I have good reasons for believing that a new City Hall should not now be built, yet, if the majority of the Council desire it should. - I think it is too important a work to be treated in such a hasty & unbusiness like manner as was done last night, ample time should have been given as asked, to examine plans with specification & estimates when furnished

I may state briefly my objections in a general way as far as time would admit for examination,

The building covers too much ground, it should not be on the line of the sidewalk at Jacques Cartier Square and is too near Gasford Street, Leucrouches on the Champ d'Armes upper walk,

It is a two story building with basement & Mansard roof, alttho better if it was smaller to afford space all round it on the lot and make it three stories instead of two,

I understand
the architect's
first sketch
was a smaller
building.

Several internal arrangements seem objectionable, & much space is lost & cost incurred by a basement 16 ft high, by the passages, & by the skylights through roof & floors, which would not occur in a smaller building one story higher,

All efforts made to secure favourable consideration for suggestions, and delay for a careful examination of these last plans, having failed, and hasty decision thereon having been then & there taken, I respectfully decline to remain on said Committee & pray the Council to substitute another name for mine.







TO HIS WORSHIP THE MAYOR, THE ALDERMEN AND CITIZENS OF THE CITY OF MONTREAL IN
COUNCIL ASSEMBLED:

The undersigned respectfully begs to lay before your honourable body the following statement:—

That a Charter was granted last Spring, at or near the close of the Dominion Parliament, to construct a Railway from or near Coteau Landing to Ottawa City, called "The Montreal and Ottawa City Junction Railway."

That, under the said Charter, the Provisional Directors met and organized their Board, and forthwith engaged Charles Legge, Esquire, Civil Engineer, to make the survey, to prepare plans, specifications and a written report of the Line.

That the plans and profile are now ready, and the Report will this week be placed in the hands of the printer.

That by the survey (carefully made, and to the entire satisfaction of the Board) Mr. Legge has secured nearly a direct line to Ottawa, with the cheapest and best grades yet found in Canada.

That a Bonus of eighty thousand dollars has been voted by the Townships of Lochiel and Kenyon, towards the construction of said line.

That other Municipalities bordering on the line, will also contribute aid by means of bonus.

That the City of Ottawa, on Thursday last, at a Public Meeting of the Corporation and Citizens, passed unanimously the following resolution:

Moved by Mr. Bronson, and seconded by the Hon. Mr. Skead, Senator: "That the City Council be requested to pass a By-Law to grant a Bonus of one hundred thousand dollars in aid of the Railway."

That the Railway will open to Montreal a direct communication by the shortest possible line, for travel and traffic, with the City of Ottawa; the distance by this line being so far shorter than by any other line, that the journey will be accomplished in four hours.

That the Canada Central from Ottawa will be completed to Pembroke within fifteen months, when it will form a junction with our Line at Ottawa.

That our projected Line can be built in eighteen months to Ottawa, thereby securing to Montreal the trade of the Ottawa valley, from Pembroke and the intermediate country, and which now mainly finds its way into other channels.

That the Grand Trunk Railway Company have, in writing, agreed to grant to our Line running facilities on their Line to Montreal, and across the Victoria Bridge, both for Passenger and Freight Trains to the Eastern States.

In view of the great benefits which the Line will confer on Montreal, and the certainty of its speedy completion, the Directors request that your Corporation do grant aid by way of a Bonus, to the amount of two hundred thousand dollars, the said Bonus to be paid from time to time, as the work progresses.

That, if the amount is granted by the Corporation of Montreal, the Directors will be thereby enabled to commence constructing the Line during the course of the ensuing winter, and will enter into such arrangements as will secure the opening of the Line between Montreal and Ottawa before 1st July, 1873, at the latest.
