WHEREAS positive information has been laid before the City Authorities, that **ATTEMPTS HAVE BEEN MADE TO SET FIRE TO PROPERTY**, since the terrible Conflagration of Thursday and Friday last; and it is the interest of every Citizen, and of the utmost importance to the public safety, that the miscreants so offending, should be detected and brought to justice:

I, the undersigned, Mayor of the City of Montreal, do hereby offer a Reward of

ONE HUNDRED POUNDS

to any person (not being the principal offender,) who will give such information as shall lead to the apprehension and conviction, of the party or parties, guilty of any of the late attempts at Incendiarism, or who may hereafter, wilfully set fire to any premises in this City, or attempt so to do.

And, under the alarming circumstances referred to above, I do hereby call upon all prudent citizens to keep strict watch over the safety of their own and neighbours' premises; and to exercise the utmost vigilance, in aid of the efforts that will be made by the Authorities, for the protection of property, and the apprehension and punishment of offenders.

La dénonciation et plainte de Louis René, Connétable de Police de la Cité de Montréal, dans le District de Montréal sus-dit, reçues ce vingt-septième jour de Juillet dans l'année de Notre Seigneur mil huit cent cinquante deux, par le soussigné, un des Juges de Paix de Sa Majesté, dans et pour le dit District de Montréal, lequel déclare que vendredi dernier le vingt-troisième jour de Juillet courant vers une heure de l'après midi, le déposant étoit dans la cour située sur la Rue Amherst de cette Cité, lorsqu'une femme qui demeure dans le voisinage donna l'alarme du feu.

Que le déposant se mit à regarder et vit du feu qui commençoit à sortir de la Couverture d'une bâtisse occupée comme tannerie par un homme qu'il a entendu nommer Edwards Shipherds, qui est sur le deuxième lot de celui occupé par ce déposant sur la Rue Amherst sus-dite.

Que le déposant courut de suite à la porte de cour de la dite tannerie sur la Rue Amherst et arriva à la dite porte de cour en même temps que

que le nommé Étienne Bleau, Charretier,
du même lieu, qui demeure au pie dans le
voisinage -

Qu'ayant trouvé la porte de Cour
suscite, fermée au cadenas et étant in-
capable de la briser seul avec le dit
Bleau et étant incapable de passer
sur la clôture parce qu'elle était haute
de près de douze pieds, et déposant
poussa le dit Bleau par dessus la clôture,
et il courut sur le lot voisin, occupé
par un nommé Rogers et alors aidé
d'un nommé Henry Popham, il cassa

Respectfully Represents

That your worshipful body having
shortly after the great fire in July
last, and previous to ^{the} fire under-mentioned,
issued a proclamation offering a
reward of one hundred pounds to any
person or persons who shall discover
or lead to the discovery of any act
of incendiarism in the City of Montreal,
your Petitioner respectfully claims
that sum of money from your wor-
shipful body for having discovered
the ~~of~~ incendiarism of Edward Shep-
herd, ~~who was convicted for~~ on a
Tannery, which ^{was} occupied by him
in Amherst Street, Quebec suburbs,
and for which he was convicted at
the last Criminal term of the Court
of Queens Bench in Montreal, and
in which trial your Petitioner appears
as a principal witness. —

The grounds upon which your
Petitioner makes this claim are as
follows: — On the twenty third

third day of July last past, at
the said City of Montreal, between
the hours of twelve and one o'clock,
at noon, & while standing
on the gallery attached to the second
story on the back of my house (which
is situate within ^{two} ~~twelve~~ yards
of the said Tannery) I saw a
small flame about the size of a
candle-light appearing through the
shingles of the roof of a building
belonging to the Tannery then occupied
by the said Edward Shepherd. I
thereupon immediately ran into the
street and shouted fire. I then
ran to the gate of the Tannery which
I found locked. With the assistance
of parties passing I got pushed
over this gate which I could not
open & by which alone I could reach
the fire. I then ran and ascended
alone the building on fire; on reaching
its roof I pulled off the shingles,
and called out for water. Before
I got any water, I pulled off all
the shingles on fire, and then I first
perceived that the fire came from
between the rafters and the shingles
where a number of small chips
and some shavings had apparently
been placed and ignited. During all
this time I was alone, I positively
can swear that ~~no one~~
was

was present when I first came to
the fire. No one came to my assistance
until I had extinguished the fire
by tearing away the burning shingles.
After I had extinguished the fire,
one of my servant men with a
Truck burst open the Tannery gate,
by which parties were enabled to
bring water and to offer assistance.
I ~~swear~~ state most positively that
the fire was extinguished, and
discovered by me. I now went
to my dwelling house to clean myself
from the dust and smoke in
which I had been enveloped by
the fire, when I was sent for
by Mr Contant of the Police, who
desired to know from me how the
fire originated. I thereupon went
to him, and showed him the place
of the fire, and recommended him
to arrest Mr Shepherd, as I pointed
out the circumstances which I had
discovered in connection ~~with~~ with it
which had led me to believe that
it was the work of an incendiary.

Your Petitioner subjoins his
affidavit of the truth of the above
statement, and also the affidavits
of Mr Henry Popham junior, and
Mr Robert Moore both of whom state
on their oaths that Your Petitioner was
the first to discover, and the party
who

who extinguished the said fire.
If your worshipful body requires
further evidence, your Petitioner
could adduce six or seven more
witnesses who can ^{also} corroborate on oath
the statement contained in the
affidavit of his present witnesses. —

Wherefore your Petitioner prays
that your worshipful body will
be pleased to give him the sum
of one hundred pounds currency
for the reasons aforesaid, in
accordance with their said Pro-
clamation. —

Henry Popbarn of the City of Montreal, Clerk, being duly sworn, deposes, and saith, that at the said City of Montreal, on the twenty third day of July last past, I was present by the fence adjoining a Tannery situate in Amherst Street in the said City, then occupied by Edward Shepherd and did see Etienne Blau of the said City, Master-Carter, standing on the gallery by the roof of building belonging to the said Tannery endeavoring by removing the shingles on the said roof to extinguish a fire which had there made its appearance. COURT OF QUEEN'S BENCH.

[CROWN SIDE]

Friday, 29th October, 1852.

Present:—The Hon. Jean Roch Rolland.

The Queen vs. James Woods, on indictment for arson. The evidence in this case was resumed this morning, and several witnesses were examined in rebuttal on the part of the crown.

His Honor Mr. Justice Aylwin charged the jury at considerable length in his usual able and masterly style, and wound up by stating the opinion of the Court, that the prisoner should not be found guilty.

The jury withdrew, and after a few moments returned a verdict of “not guilty.” Mr. Carter, Counsel for prisoner.

Hiram Moore *alias* Hiram William Moore, on indictment for Bigamy, withdrew his plea of *not* guilty, and pleaded guilty.

Bernard McMahon, a private soldier in Her Majesty's 20th Regt., was tried for stabbing a fellow soldier of the same Regiment, named Joseph Law, with a knife with intent to murder, and found guilty on the clearest evidence. The prisoner offered no defence, and must have been a bad character in his Regiment; for, although the Court-room was crowded with officers and men of his Regiment, he called no witnesses even as to character.

The following sentences were passed by the Court:—

Cecille Mignette, larceny, six months jail, hard labour.

Adelaide Mautas, do, 3 months do.

Margaret Brown, do, 3 months do.

Mary Ann Graham, convicted of assault, 1 year hard labour.

George Fiset, larceny, recommended to mercy, 3 months jail, hard labour.

James Frederick Smith, on indictment for obtaining a valuable security, under false pretences, two years penitentiary.

Mathew Chadburn, assault, one year jail, and hard labour.

Thomas Wych, larceny, convicted of knowingly receiving stolen goods, 3 years penitentiary.

Thomas Wych, on another indictment, convicted of receiving stolen goods, 3 years penitentiary, after expiration of first sentence.

Joseph Breen, assault, 1 year jail, and hard labour.

Mary Hasey, Larceny, 3 months jail, and hard labour.

David Gormley, stealing from the person 7 years penitentiary.

X Edward Sheppard, arson, 14 years penitentiary.

John Kearney, the elder, shooting with intent to murder, recommended to mercy, 2 years penitentiary.

Hiram Moore *alias* Hiram Wm. Moore, bigamy, 7 years penitentiary.

Bernard McMahon, stabbing with intent to murder. Judgment of death, in this case, was not pronounced by the Court, but was ordered to be recorded, and is now recorded:

“That the Prisoner be taken from hence, to the Common Jail of this District, from whence he came, and from thence to the common place of execution of this District, and that he be then and there hanged by the neck until he be dead.”
