JEAN BOCHART, Knight, Seignior of Champigny, Noroy and other places, Councillor to the King in his Councils, Intendant of Justice, Police and Finances in the said Country.

Considering the petition presented to us by the Reverend Father Martin Bouvart, Superior of the Society of Jesus in this country, and Father François Vaillant its procurator, praying that we might be pleased to transfer to them as their own property the fief, land and seigniory of Sillery, which they now enjoy only as administrators of the property belonging to the Christian Indians, to whom the said fief had been granted by His Majesty in the month of July one thousand six hundred and fifty one, and which the said Indians have been obliged to abandon ten or twelve years since, to go and establish themselve elswhere, as well because the soil under culture was entirely worn out, as because the fire wood, which has been cut for forty years, is now very far from their residence, and also to transfer to them as their own property and in fief four perches of land in front by eight in depth, conceded by the lete M. De Montmagny, and an augmentation of forty toises square, conceded by the late M. Daillebout, both Governors General of this country, to the late Pachiriny, an Indian Chief at the place called Three Rivers, of which the said Jesuits, as guardians and administrators of the property of the said Pachiriny, have granted, since more than forty years, deeds of concession to divers French individuals to occupy them and erect buildings thereon as they have done, for a small rent, which said Pachiriny is deceased, and the said Jesuit Fathers have remained in the enjoyment of the said tracts of land, whereof they now pray us to grant them a title of concession; and being fully informed of the good intentions of the said Fathers of the Society of Jesus, of the gifts and great spiritual and temporal assistance which they render to the Indians of this country, and of the great care which they have taken and of the heavy expenses which they have incurred in order to maintain the missions amongst the said Indians, and labour efficiently for their salvation, and particularly with regard to those who were settled at Sillery aforesaid, for whom, since they left that

place, they have bought at their own expense other lands in divers places in this country with the view of establishing them thereon, without which they would have dispersed;

For these reasons, We have given, granted and conceded to the said Jesuit Fathers as their own property the said fief, land and seigniory of Sillery, of one league in width on the River St. Lawrence, by one league and a half or thereabouts in depth, running as far as the seigniory of St. Gabriel which bounds it in the rear, commencing on the north east side at the Pointe de Puisseaux and on the south west side at a line which divides it from the fief Gaudarville, which lines have been drawn, the one about twenty-five years ago, and the other about forty, with all the rights and privileges formerly granted to the said Indians, to enjoy the whole as a true fief, held only of the King, with the right of superior, mean and inferior jurisdiction (haute, moyenne et basse justice), as they now hold all the other lands which His Majesty has been pleased to grant them in this country;

And we, also, grant, give and concede under the same title of fief and with the same rights and privileges as above specified, the said four perches of land in front by eight in depth conceded by the late M. De Montmagny, and the twenty square toises of augmentation conceded by the late M. Dailleboust, both governors general of this country, to the said late Pachirigny, Indian chief; the whole to be enjoyed by them as their own property for ever, agreeably to the Custom of Paris, subject to the condition that the appeals from the jurisdiction of Sillery aforesaid shall lie before the lieutenant general of the provostship of Quebec, and that the said Jesuit Fathers shall be bound to have these presents ratified by His Majesty within one year.

Missions established in this city, stating that the said Bishop has the usufruct, and that the said Seminary owns the property, as his donees, of the island called Jesus, including the Isle aux Vaches and other adjacent islands, which are held in fief and seigniory, with jurisdiction, and are situate in this colony at the north side of the island of Montreal, the whole made over by way of exchange to the said Bishop of Quebec by Monsieur Berthelot, Councillor and Secretary to the King, under a contract passed before Carnot and his colleague, notaries, at Paris, on the twenty-fourth day of April one thousand six hundred and seventyfive, which said Mr. Berthelot was proprietor thereof as well in virtue of the cession and abandonment of the same which had been made to him by the Reverend Father Dablon, Superior of the Missions of the Society of Jesus in this country, by contract passed before Becquet, notary, at Quebec, on the seventh day of November one thousand six hundred and seventy-two, as in consequence of the concession thereof which had been made to him by Mr. Talon, Intendant in this country, on the twenty-seventh day of October one thousand six hundred and seventy-six, since which he has enjoyed the same, having caused considerable buildings and clearings to be made thereon; but as there is no confirmation by His Majesty of the concession which had been made thereof, first by Messieurs of the said Society, and afterwards by Mr. Talon, the said Bishop and the said gentlemen of the Seminary have requested us to make provision in this behalf; considering the said petition, the two deeds of concession and the titles above mentioned, and having a perfect knowledge of the peaceful possession and enjoyment of the said Islands by the said Bishop and the said gentlemen of the Seminary since the twenty-fourth day of April one thousand six hundred and seventy-five, when they were made over to them by the said Mr. Berthelot;

We, under and in virtue of the power jointly entrusted to us by His Majesty, have renewed the concession made by the said Monsieur Talon, in consequence of the want of confirmation thereof by His Majesty, and have, under His Majesty's pleasure, as far as may be necessary, given and conceded unto the said Bishop of Quebec, and the said gentlemen of the Seminary, the said Island of Jesus, the said Isla aux Vaches and other adjacent islands: To have and to hold the same unto them, their successors and assigns, in fee, for ever, under the title of fief and segniory with superior, mean and inferior jurisdiction (haute, moyenne et basse justice) according to the Custom of Paris which shall be followed therein, and on condition that the appeals shall lie before the Royal Judge at Montreal, and that they shall have these presents confirmed by His Majesty within one year.

We, in virtue of the power jointly entrusted to us by His Majesty, have given, granted and conceded, and by these presents do give, grant and concede to the said Sieur Lefevre the said lands as hereinabove described, to have and to hold the same unto him, his heirs or assigns as their property for ever, under the title of fief and seigniory, with the right of hunting, fishing and trading with the Indians throughout the whole extent of the said concession, subject to the condition of paying fealty and homage (fiethomnage) at the Castle of St. Louis at Quebec, of which he shall hold under the customary rights and dues agreeably to the Custom of Paris, followed in this country; that he shall preserve and cause to be preserved by his tenants the oak timber fit for the building of His Majesty's ships; that he shall give notice to the King or to the governor and intendant of this country of the mines, ores or minerals, if any be found within the extent of the said concession, and that he shall immediately clear the said lands, that he shall immediately keep and cause to be kept thereon house and home (feu et lieu), and lastly that he shall leave the roadways and passages necessary for the public use; the whole under the pleasure of His Majesty, by whom he shall be held to have these presents confirmed within one year, on pain of nullity of the same.
