1910, 16 novembre

Le Conseil de Maisonneuve charge son aviseur légal,
M.L.J.S.Morin, de surveiller les intérêts de la
Ville devant la Commission des Chemins de fer au
sujet de la jonction du Montreal Terminal Railway
et du Pacifique Canadien, à la traverse de la rue
Moreau.

1911 26 mai

Le Conseil de Maisonneuve décide de notifier le
Pacifique Canadien qu'il s'oppose formellement à ce
que la Compagnie obtienne un droit de passage sur
toute autre partie du territoire de la municipalité
que celle qui longe le côté nord des voies existantes
de la Cie du Terminal et du Great Northern Rly.

1912 19 avril.

Dans un rapport qu'il adresse au Secrétaire de la Commis-
sion des Chemins de fer, M. Geo. A. Mountain, Ingénieur en
Chef, laisse entendre que la ville de Montréal ne s'oppose
pas à l'établissement de cette ligne, mais qu'elle exige
que l'espace réservé aux rues traversant cette voie reste
entièrement libre.

1912 22 mai

Le Conseil de Maisonneuve proteste de nouveau contre les
représentations de l'ingénieur Mountain en ce qui regarde

Conseil de ville s'en tient à l'établissement de cette
voie projetée, en bordure des voies du Montreal Terminal.

1912 29 juin

déclare que M.G.A.Mountain sacrifie ni plus ni moins

1912 13 juillet

Ordonnance no 16,998 de la Commission des Chemins de fer du Canada par laquelle le Pacifique Canadien est autorisé de construire un embranchement longeant la rue Forsyth, dans le quartier Hochelaga, dans la municipalité de Maisonneuve, dans le quartier de la Longue-Pointe, la municipalité de St-Jean-de-Dieu.

1912 6 novembre

M. L.J.S.Morin, aviseur légal de la municipalité, donne à entendre que la Commission des Chemins de fer a suspendu, le 5 novembre, jusqu'à janvier 1913, l'ordonnance rendue le 13 juillet 1912. Ordre a été donné de suspendre tous travaux de construction et procédures en expropriation pour que dans l'intervalle, la ville de Maisonneuve, de concert avec la compagnie du Pacifique Canadien, fasse diligence pour saisir le Gouverneur en Conseil de la décision des Commissaires.

1913 12 février

L'ingénieur J.-Emile Vanier approuve les vues de l'ingénieur Marius Dufresne sur la suggestion émise de concentrer sur un parcours unique les voies de chemins de fer dans le territoire de Maisonneuve.

1913 19 mai

Le Conseil Privé, à Ottawa, rejette la requête de la municipalité de Maisonneuve et reconnaît au mérite la légitimité de l'Ordonnance de la Commission des Chemins de fer autorisant le Pacifique Canadien de construire l'embranchement projeté.

1913 2 juin.

M. L.J.S.Morin, aviseur de Maisonneuve, est prié par le Conseil municipal de Maisonneuve d'insister auprès de la Commission des Chemins de fer ou auprès du gouvernement fédéral pour que la voie projetée du Pacifique Canadien soit élevée dans toute la largeur de la municipalité.

1913 17 juillet; Copie de la demande adressée à la Commission des Chemins de fer par la Compagnie du Pacifique Canadien pour obtenir une ordonnance en vue de construire l'embranchement projeté de la rue Forsyth.

1913 2 août; Mise en demeure et protêt servi par la municipalité de Maisonneuve à la Cie du Pacifique Canadien.

1914 7 mars; Le Conseil de Maisonneuve proteste énergiquement contre le projet de construire une voie avec viaducs et traverses à niveau dans le territoire de Maisonneuve.

1914 3 avril; Le Chef de Police Marchessault est autorisé par le Conseil municipal de Maisonneuve de surveiller tout commencement de travail que le Pacifique Canadien pourrait exécuter dans Maisonneuve pour l'établissement d'une nouvelle voie et d'empêcher par tous les moyens l'exécution de ce travail.

1914 19 août; Le Conseil municipal de Maisonneuve demande aux autorités administratives de Montréal de bien vouloir intervenir en faveur de Maisonneuve dans la requête présentée par le Pacifique Canadien à la Commission des Chemins de fer, de façon à ce qu'il soit permis de construire des voies élevées dans les territoires de Maisonneuve et d'Hochelaga.

I have received instructions from the Council of the Town of Maisonneuve to bring to your knowledge that it would be in the interest of your Company and the Town of Maisonneuve to extend your railway lines in the limits of the Town of Maisonneuve, which is growing very rapidly.

In fact, the Town of Maisonneuve, according to statistics, is the third centre as manufacturing centre. There is at present over twenty-five factories in our limits and we expect to nearly double the number of factories within a short period.

The transportation of goods is made at present by cartage which does not give enough accommodation.- Twenty-five to thirty double rigs are employed for that purpose and this number should be increased to fifty or seventy-five.

The Vickers Maxim Co., the large steamer builder are going to establish their plant in the limits of Maisonneuve. The United Shoe Machinery Co. is at present located here. The Steel Co. is also erecting its plant in Maisonneuve.

Several times we have been asked by our manufacturers to induce your Company to extend its lines here.

For that purpose the Town of Maisonneuve progressing so rapidly we thought that your Company should extend its line and construct a station with sheds &c., in our limits.

Your letter of 24th instant respecting the plan of this Company's proposed branch line through Maisonneuve, has been received.

I am very sorry that the plan does not meet with approval of the Town Council but I think that upon reconsideration your clients will conclude that the suggestion that we should build the line close and parallel to the Canadian Northern is not feasible. The line is being constructed for the object of developing and serving industries and would be rendered almost entirely useless for this purpose if constructed alongside the existing railways.

I am very much obliged for your offer to co-operate with the Company in the selection of another route, but I am afraid any other route would be impracticable. If, however, you think a conference desirable I shall be very glad to meet the representatives of the Town Council and yourselves at any

ASSISTANT CHIEF COMMISSIONER:-

285/912 This matter was heard before the late Chief Commissioner and Myself in Montreal on the 22nd February last. It was referred to Mr. Mountain to report upon, and with certain minor changes he recommended the granting of the application. The late Chief Commissioner was, I believe, prepared to grant the application, but no order was issued prior to his death.

We have recently had some correspondence with the City of Montreal and the Town of Maisonneuve, and have also considered an objection raised to the proximity of the proposed track to Lasalle College. Mr. Commissioner McLean and I on Monday last visited the location of the proposed track south east of Lasalle College, and also considered the suggestion of the Town of Maisonneuve to divert the line in a south-easterly direction so it will adjoin the Canadian Northern Quebec Line through Maisonneuve to the south-east of the Warden King premises. That suggestion would necessitate a number of level crossings in the Town of Maisonneuve, and other difficulties, which they satisfied us that notwithstanding the position taken by the Town of Maisonneuve the line applied for by the Company, as recommended by Mr. Mountain, should be adopted. We realize the necessity of having the line kept as far from Lasalle College as possible, and on Mr. Mountain's recommendation, the portion of the line passing the college will be diverted southward so as to allow of atleast 25 feet more space between the track and the College.

I therefore think an Order should go granting the line applied for with the modifications which Mr. Mountain will mark upon the plan.

Gravel, such omission from the said plan having arisen from mistake.

Upon reading what has been filed in support of and in opposition to the application, and upon hearing the matter at the sittings of the Board held in the City of Montreal on February 22nd, 1912, in the presence of counsel for the Applicant Company, the City of Montreal, the Town of Maisonnette, the Montreal Street Railway Company, the Montreal Light, Heat and Power Company, and certain land owners affected, other land owners interested appearing in person; upon the report and recommendation of an Engineer of the Board, concurred in by its Chief Engineer; and upon the inspection of the location by the Board.

IT IS ORDERED:

1. That the Applicant Company be, and it is hereby authorized to construct, maintain, and operate the said branch line of railway from a point on the main line of its railway about six hundred and fifty (650) feet south-easterly from the south easterly side of Forsyth Street, in Hochelaga Ward of the City of Montreal; thence northerly and north-easterly through primitive lots Cadastral Numbers 140 and 80 of the Incorporated Village of Hochelaga, and thence along the north-westerly side of Forsyth Street of the boundary line between the said





In the matter of application of the Canadian Pacific Railway for authority to construct a branch line from a point on their railway near Forsyth Street and Moreau Street, Montreal, to appoint in the parish of Longue Pointe, P.Q., would say that I heard the evidence in this case, and examined the ground. I also had Assistant Engineer Belanger make a careful examination of same.

The application was originally to run this line on the ground level, as shown on the plans and profiles filled with the Board. After the hearing the C.P.R. filed a new profile, marked "A", which is attached to this report, that show a track elevation proposition as far as Letourneux Street, Maisonneuve. The City of Montreal through which a portion of this line runs does not raise any objections, except from the point of view that they want the streets opened full width instead of the narrow openings opposite these streets proposed by the Canadian Pacific Ry. I am of the opinion that the location is a proper one through the City of Montreal provided the contention of the City of Montreal, to leave the streets with full width openings is complied with.

Most of these subdivisions through which these streets run are narrow, and only take about one street to a subdivision, and it would be difficult to make a subway for two different subdivisions. There are one or two streets not opened across Forsyth Street, but there is an allowance for a street on the ground, and buildings are going up on these streets south of Forsyth Street, which indicates to me that the openings must be left there if this land is to be of any value to the north of Forsyth Street for residential purposes. Valois Street is the only one that might be left with a 30 foot opening, as it only runs into a quarry.

The location then runs through the Town of Maisonneuve, and the new profile proposes track elevation to Letourneux Street, from which the grade falls to the level of the ground at the rear of Warden Kings' property at Aird Street. The representatives of the Town of Maisonneuve suggest an alternative plan and profile, which is submitted with this report,

This is about 100 feet north of the centre line of the C.P.Ry. The School Commission desire to extend south in order to get playgrounds for the school, but it is quite possible to get good grounds right back of the school house instead of extending to the south. This street will be depressed about three feet to allow for a 12 foot subway. As there will not likely be any street cars up there on account of them being at present up the adjoining street, Lasalle Avenue, I think the 12 foot headroom should be satisfactory. The line then continues on the level from Aird Street across Fifth, Fourth, Third, Second and First Avenues, which are graded and opened, but on which there are no buildings, the land being vacant, and most and most likely will be used for industrial purposes. This last mentioned property is controlled by Senator Mitchell, and Assistant Engineer Belanger called upon him in reference to the crossing of this piece of land. He is in favour of the proposition of the Town of Maisonneuve rather than have his land out up 700 feet north of

the Terminal Railway Company's line, but is a case in my mind of escaping one objection to meet others, that in view of the buildings would be a greater damage. At any time that this was built on, and heavy business on the streets, then of course the track elevation could be continued beyond this point, but in the opinion of the Board's Engineers it is not necessary at this time.

The line next runs through the Longue Pointe Ward of the City of Montreal. Through this portion the route runs parallel and adjacent to the present line of the Montreal Terminal Ry. and the C.N.Q.Ry. It also runs across the Municipality of St. John de Dieu, the location here being adjacent to the aforementioned railways, and in fact it is the only location it could be take there. They could not go south on account of the railways, and if they go north they will interfere with the Asylum for the Insane buildings at Longue Pointe. It crosses three spurs of the Montreal Tramways to different industries, and these crossings will have to be provided for by the Canadian Pacific Ry.

Under the above conditions the Board's Engineers recommend that the location of the Canadian Pacific Railway be approved of.



Mr. Geo. Mountain's report dated the 19th of April 1912 concerning the location of C.P.R. tracks in Maisonneuve, has been submitted to the Council of this Town at its meeting of the 22nd instant; and I have been authorized by said Council to emphatically protest against said report and against the location of said track in Maisonneuve, and the Council insists that the location be made along the track of the Montreal Terminal Rly. Co., as suggested by the plan and profile filed with your board by the Town of Maisonneuve.

As to the declaration saying that the line goes through the combined station of the Montreal Terminal Rly. & the C.N. Rly., at Lasalle Ave., your board has decided recently that the C.N. Rly. Co. should buy a land and build a station in the limits of Maisonneuve and we are informed that the C.N. Rly. Co. will buy on the south side of its track.

The station of the Montreal Tramways Co. is also to be removed from that place.

As to the other declaration that the school is about 100 feet north of the centre line of the C.P.R. Rly., I declare this wrong because the C.P. Rly. plan shows that one or two lots belonging to the School Commissioners are going to be expropriated for that purpose, and the School Commissioners cannot extend at the back of their school because the land is bounded at the back by a public lane and this lane cannot be blocked for no reason: it would be impossible to get the consent of the parties having rights of way in that lane and finally the Town of Maisonneuve and its inhabitants will never agree to cut in three portions its territory by 2 railway tracks at a distance varying from



In answer to the report made to the Railway Commissioners by Mr. G.A. Mountain Chief Engineer of the Commission, I have to say that Mr G.A. Mountain makes great errors of description to the disadvantage to the interests of the Town of Maisonneuve, so sacrificing the public interest to the advantage of a company.

According to the plan submitted by the Town of Maisonneuve, we keep the proposed line of the C.P.R. in the City of Montreal up to Valois street. In regards to the proposed line through the Longue Pointe ward, the two schemes are similar; the C.P.R. line will run parallel and adjacent to the present line of the Montreal Terminal Railway and the C.N.Q.Ry. The only difficulty exists in the raccording line between Valois street and the Longue-Pointe ward.

According to the proposed line submitted by the C.P.R. the line would run alongside Forsyth street on a certain distance, then will go north four or five hundred feet crossing Warden King's property, then continued parallel to Earnest street, up to the east limits of the Town of Maisonneuve, from that point by a curve comes alongside the line of the Terminal Ry Co. and C.N.Q.Ry.

The proposed line submitted by the Town of Maisonneuve as shown on the plan runs alongside the line of C.N.Q.Ry., from Pie 1X Ave. up to the C.P.R.'s property in the Longue Pointe ward. From Valois Ave. to Pie 1X Ave, the two points will be connected by a curve.

According to Mr G.A. Mountain's statement the proposed line submitted by the Town of Maisonneuve would affect the traffic of Forsyth street "It is the most important street in this vicinity" that is a mistake because Forsyth street is only 60 feet wide, it is not macadamized, without side-walks the same street is located at about 900 feet north of Ontario street, which is one of the three main streets on which there is a double track of tramways. This same Ontario street runs through the City of Montreal, the Town

of Maisonneuve and the Longue Pointe ward, it has been homologated at 66 feet wide up to the C.P.R. property in the Longue Pointe ward, therefore Forsyth street is not the most important street of the vicinity as Mr. Mountain states

By the proposed line submitted by the Town of Maisonneuve, Earnest street in Maisonneuve will be depressed some 6 feet, to obtain a height of 15 feet clearance underneath the girders, this depression would not affect the traffic of Forsyth street, because the greatest depression would be in the Town of Maisonneuve, which consents to modify the profile of that street at its own expense to obtain a 3 per cent grade for the approaches of the viaduc

According to Mr. Mountain's statement, the proposed line submitted by the Town of Maisonneuve will cross the track of the Montreal Tramways at Pie IX Avenue, it would mean a diamond crossing, this is true, I wish to remark that the Montreal Tramways line has a level grade diamond with the C.N.Q.Ry., and actually the Montreal Tramways is obliged to take care of the signals, so another diamond would not mean more work and more inspection for the company.

In his report, Mr. Mountain said "from there the line runs north and adjacent to the Montreal Tramways line interfering with industries and buildings from Pie IX Avenue to Fifth Avenue including the warehouse of the Warden King, the Soap Co's property and the Dominion Light Heat & Power Co. station".

Between Pie IX and Fifth Avenue, the suggested line will cross the Neverslip Co's property, but these shops are closed since a certain time, then the line will cross a Box Factory, the Montreal Last Manufacture, the warehouse of the Warden King, the Soap Co's property and the Dominion Light, Heat & Power Co. station.

In regards to the warehouse of the Warden King, it could be located at the north side of the shop were they have a great area of vacant ground, there offices can be moved about 100 feet to the west of the present location as far as the other industries are concerned they can located themselves at any other site of the Town of Maisonneuve with as much advantage. "It also goes through the combined station of the Montreal Tramways and the C.N.Q.Ry, at Lasalle Avenue states Mr. Mountain; I wish to remark that the C.N.Q.Ry, as no station in the Town of Maisonneuve, at Lasalle Avenue where its passengers train stop actually, the Company was force some time ago to stop its train be-

cause there was only single track at that point for the Montreal Tramways and the C.N.Q.Ry., to-day the C.N.Q.Ry., at Lasalle Avenue has no agent either to give informations or to sell passage tickets, it has no telegraph office, in regards to the Montreal Tramways it rents two rooms as offices for its local line from Maisonneuve to Bout de l'Isle. The other part of the building is occupied as restaurant.

In this report Mr. Mountain suggest the closing of Charlemagne Street saying that the same street is intended to be closed as the Power Line runs up to the center of it, this is a mistake, the Town of Maisonneuve dont mean to close that street because last spring it has expropriated part of it, south of Girard Street, about the Power line it runs on the West side of Charlemagne street on the first row of lots of subdivision of farm No 18 which are the property of Shawinigan Water & Power Co.

By its proposed line, at Letourneux Avenue, the C.P.R. would run its line at about 100 feet south of a large school house recently built, and to obtain its right of way it would be oblige to expropriate part of the School Commission's property. The vicinity of a railroad would make a great inconvenience for the scholars.

Mr. Mountain forgot to mention in his report that the propose profile of the C.P.R., as approved by him will modify all the profiles of the avenues and this will be a great injury to the interest of the Town of Maisonneuve. Alongside the C.N.Q.Ry's line, the profiles of the avenues were made to accommodate the location of many tracks. In locating the propose line of the C.P.R. alongside the line of the C.N.Q.Ry., the wish of the Town of Maisonneuve is to locate all the railroads close to each other so that if a company is obliged to have elevated tracks the other will be forced to do the same and the Town instead of being crossed by different railroads at many different places, which will affect the general progress, will gain by getting all the railroads altogether.



ASSISTANT CHIEF COMMISSIONER:

This matter was heard before the late Chief Commissioner and myself in Montreal on the 22nd February last. It was referred to Mr. Mountain to report upon, and with certain minor changes he recommended the granting of the application. The late Chief Commissioner was, I believe, prepared to grant the application, but no Order was issued prior to his death;

We have recently had some correspondence with the City of Montreal and the Town of Maisonneuve, and have also considered an objection raised to the proximity of the proposed track to LaSalle College. Mr. Commissioner McLean and I on Monday last visited the location of the proposed track south east of LaSalle College, and also considered the suggestion of the Town of Maisonneuve to divert the line in a south easterly direction so it will adjoin the Canadian Northern Quebec Line through Maisonneuve to the south-east of the Warden King premises. That suggestion would necessitate a number of level crossings in the Town of Maisonneuve, and other difficulties, which they satisfied us that notwithstanding the position taken by the Town of Maisonneuve the line applied for by the Company, as recommended by Mr. Mountain, should be adopted. We realize the necessity of having the line kept as far from Lasalle College as possible, and on Mr. Mountain's recommendation, the portion of the line passing the College will be diverted southward so as to allow of atleast 25 feet more space between the track to the college.

I therefore think an Order should go granting the line applied for with the modifications which Mr. Mountain will mark upon the plan.

That level railway crossings within populous urban centres are a great evil, resulting in many deaths and serious accidents, and no new ones should be created ; that Montreal and its immediate suburbs (which together constitute one urban centre) suffer heavily from this cause, and experience proves that, with the vast and rapid expansion, it is specially dangerous there to introduce new level crossings ; that the Railway Commission has issued an order permitting a series of seven level crossings across the large city of Maisonneuve, containing 36,000 population, which is practically part of Montreal, and one of its most rapidly increasing parts ; that such an order is contrary to public welfare ; that an appeal to you has been taken ; and it is in the public interest that such appeal should be granted.

That level railway crossings within populous urban centres are a great evil, resulting in many deaths and serious accidents, and no new ones should be created ; that Montreal and its immediate suburbs (which together constitute one urban centre) suffer heavily from this cause, and experience proves that, with the vast and rapid expansion, it is specially dangerous there to introduce new level crossings ; that the Railway Commission has issued an order permitting a series of seven level crossings across the large city of Maisonneuve, containing 36,000 population, which is practically part of Montreal, and one of its most rapidly increasing parts ; that such an order is contrary to public welfare ; that an appeal to you has been taken ; and it is in the public interest that such appeal should be granted.





I duly received your letter of 10th instant, enclosing copy of your Solicitor's opinion regarding the levying of taxes upon our railway poles, wires and ties on Jeanne d'Arc Street, in your Municipality.

We do not agree with the views expressed by your Solicitor. In a case of the Central Vermont and the Town of St. Johns, it has been decided by the Supreme Court and confirmed by the Privy Council, that by the terms of section 326, 4501, R.S.Q., and 720 M.C., no part of the Railway is made taxable property except the land as land occupied by the road.

We will certainly resist any attempt on the Municipality's part to collect any of these taxes.




